KEC International wins orders of ₹ 1243 crore

Mumbai, March 05, 2015: KEC International Ltd. (KEC), a global infrastructure EPC major, an RPG Group company has secured new orders of ₹ 1243 crore in its Transmission & Distribution, Railways and Cables businesses. Details are as follows -

Transmission & Distribution Businesses:

In this business, the Company has secured orders in India, Saudi Arabia and the Americas amounting to ₹ 995 crore.

- **India:** Three turnkey orders secured from Power Grid Corporation of India Limited; an order for 765 kV transmission line, another for 220/33 kV GIS substation and third for 400 kV transmission line.
- **Saudi:** Two orders secured from Saudi Electricity Company; an order for construction of 380 kV Overhead Transmission Line (OHTL) and another, for shifting of 380 kV and 132 kV OHTL.
