Mumbai, July 27, 2015: KEC International Ltd. (KEC), a global infrastructure EPC major, an RPG Group Company, today, announced its unaudited consolidated financial results for the quarter ended June 30, 2015.

Consolidated Financial Performance

Net Revenue for the quarter increased by 9.1% Y-o-Y at ₹ 1,877.9 crore as against ₹ 1,720.7 crore in the corresponding quarter of previous year.

EBITDA for the quarter increased by 38.3% Y-o-Y at ₹ 140.7 crore as against ₹ 101.7 crore in the corresponding quarter of previous year. EBITDA margin for the quarter increased to 7.5% as compared to 5.9% in the corresponding quarter of previous year.

Profit After Tax (PAT) for the quarter increased by 167.5 % Y-o-Y at ₹ 30.4 crore as against ₹ 11.4 crore in the corresponding quarter of previous year.

The **order book** currently stands at ₹ 10,537 crore as compared to ₹ 10,325 crore in the corresponding quarter of previous year.
