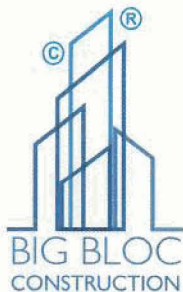
This is to inform you that the Board of Directors of the Company, in its meeting held on Tuesday, the 14th December, 2021, have:

The Board of Directors in their meeting held on 14th December, 2021, has discussed on the expansion of the business through Joint-venture with SCG (Siam Cement Group) and has approved the draft of Joint Venture Agreement as sent by Khaitan & Co. after necessary modifications.
