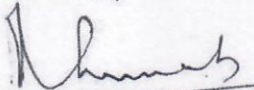

Thank you for your letter. I would like to bring to your notice the following points with regards to the queries raised in your letter:

1. The notarised Letter of Administration (LOA) that was attached with my letter dated 8th February 2022 is the only LOA issued by the court with regards to my father's estate, since my father passed away without a will we did not have an exact idea as to the amount of shares he was holding in physical state and hence all holding have not been recorded in the LOA schedule.
2. The share certificates also have been misplaced, and we were only made aware of the holdings due to the Dividend Warrants sent from the company.
