CERTIFIED TRUE COPY OF THE EXTRACT OF THE MINUTES OF THE MEETING OF THE BOARD OF DIRECTORS OF GINNI FILAMENTS LIMITED HELD ON JULY 27, 2021.

To consider and approve the requests received for re-classification of certain shareholders from 'Promoter and Promoter Group' category to 'Public' category.

The Board was informed of the request received by the Company on June 28, 2021, from certain promoter shareholders ("Outgoing Promoters"), to re-classify their shareholding in the Company from the category of 'Promoter and Promoter Group' to the category of 'Public' shareholding. Further, the names of the following Outgoing Promoters are requested to be removed from the 'Promoter and Promoter Group' of the Company:

The Board was informed that the reason for such re-classification is that the Outgoing Promoters are no longer associated with the business of the Company in any manner, and do not exercise any control over the Company, directly or indirectly, or have any influence over the business and policy decisions made by the Company. Further, the Outgoing Promoters are not engaged in the day-to-day affairs of the Company.

The Board was also informed that the Outgoing Promoters satisfy all conditions specified in sub-clauses (i) to (vii) of clause (b) of sub-regulation (3) of Regulation 31A of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations").

Further, as required under Regulation 31A(3)(c) of the Listing Regulations, the Board also noted that:

- the Company is compliant with the minimum public shareholding requirements as required under regulation 38 of the Listing Regulations;
- trading in the equity shares of the Company have not been suspended by the stock exchanges where the equity shares of the Company are listed ("Stock Exchanges"); and
- the Company does not have any outstanding dues to the Securities and Exchange Board of

India, the Stock Exchanges or the depositories.

Also as per SEBI Circular dated May 05, 2021, under the proviso with respect to the provision of Regulation 31A (3)(III) (a) whereby the promoter(s) seeking reclassification shall not be required to seek shareholders approval in cases where the promoter(s) seeking reclassification do not hold more than 1% (one percent) of the total voting rights in the listed entity.

Accordingly, on the basis of the rationale provided by the Outgoing Promoters and the confirmation that they satisfy the requirements of Regulation 31A of the Listing Regulations, the Board was of the view that the requests made by the Outgoing Promoters for re-classification of their shareholding in the Company be accepted and approved. However, the approval of the Board is subject to the further approval of National Stock Exchange of India Limited, and any other consents and approvals which may be required in this regard.

The Board was also informed that none of the Directors of the Company are interested in this resolution.

The Board considered the matter and passed the following resolutions:
