LIMITED REVIEW REPORT

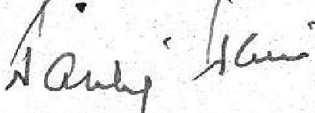

- Previous year figures have been regrouped or reclassified wherever necessary.

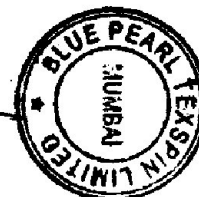

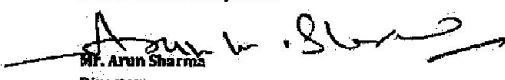
