Opposition-ruled States can't say 'no' to new citizenship law: Centre

New Delhi, December 13
Though Union Home Minister Amit Shah made it clear while replying to a debate on the Citizenship (Amendment) Bill on Wednesday that the law will be implemented in all States, many Opposition-led State governments have come out against the law stating that it is anti-Constitutional.

Chief Ministers such as Mamata Banerjee, Pinarayi Vijayan, Capiatn Amrinder Singh, Bhupesh Baghel and Kamal Nath announced that the law will not be implemented in their States. The Centre, however, said the Constitution does not allow the States to take a different approach and maintained that the CAB will be applicable to all States. Kerala Chief Minister Pinarayi Vijayan said on Thursday that the Bill reflects the ideology of the RSS and not the inclusive framework of the country's Constitution. "The Bill polarises people on communal lines. It is against the unity of the country. This Bill will not withstand the judicial scrutiny," Vijayan said and added that the BJP's attempt to create a theocratic

Hindu Rashtra will be challenged. Punjab Chief Minister Amrinder Singh said the Bill is a direct assault on the secular character of the country and the Punjab government will

not implement the legislation in the State. Congress leader and Chhattisgarh Chief Minister Bhupesh Baghel said the Act is unconstitutional. "Whatever decision is made

at the Congress party forum on the Bill will be applied in Chhattisgarh," he said. Senior Congressman and Madhya Pradesh Chief Minister Kamal Nath said: "Whatever stand the Congress party has taken on Citizenship Amendment Act, we will follow that. Do we want to be a part of a process that sows seeds of divisiveness?"

A Home Ministry official told reporters that State governments have no powers to reject the implementation of the Act as the legislation was enacted under the Union List of the 7th Schedule of the Constitution.

Mamata plans protest rallies across Bengal

Kolkata, December 13
West Bengal Chief Minister Mamata Banerjee reiterated on Friday that the amended Citizenship Act will "never" be implemented in West Bengal. The CM said her party will organise consecutive protests rallies across the state beginning December 16.

Banerjee joins the list of non-BJP ruled State CMs like

Madhya Pradesh, Punjab, Chattisgarh and Kerala who have claimed that there will be no implementation of the new Citizenship Act.

"We will never allow NRC exercise and Citizenship Act in Bengal. We will not implement the amended Act, even though it has been passed in Parliament. The BJP can't just bulldoze the states to implement it," Banerjee said adding that

she will postpone her scheduled visit to Delhi later this month.

The Trinamool Congress supremo has also called for a meeting of her party's core committee on December 20 to finalise a strategy on how to deal with the new Citizenship Act and mobilise support against it. Banerjee herself is expected to hit the streets and lead protest rallies.

Lok Sabha wraps up Winter Session with 116% productivity

Both the Houses of Parliament witnessed an eventful Winter Session that concluded on Friday. The Rajya Sabha passed 15 and the Lok Sabha passed 14 Bills, respectively, during the 20 sittings that started from November 18. 15 Bills were passed by both the Houses, which include the controversial Citizenship (Amendment) Bill.

The Parliamentary Affairs Ministry said the productivity of Lok Sabha was 116 per cent, while in Rajya Sabha it was 100 per cent. First batch of Supplementary Demands for Grants for this fiscal year was also discussed and approved along with the Appropriation Bill in the both the Houses.

Important Bills

The Centre claimed that the passage of Transgender Persons (Protection of Rights) Bill will strengthen social and gender justice system in the country. "The Citizenship (Amendment) Bill, 2019 will make refugees who are Hindus, Sikhs, Buddhists, Jains, Parsis and Christians from Afghanistan, Bangladesh and Pakistan, eligible for citizenship which will entitle them to a dignified life in India," the Parliamentary Affairs Ministry claimed.

With the Special Protection Group (Amendment) Bill, SPG will now provide security to the Prime Minister, and mem-

bers of his immediate family residing with him at his official residence, the Centre claimed. The Taxation Laws (Amendment) Bill, the Chit Funds (Amendment) Bill and the International Financial Services Centres Authority Bill were the other Bills that were passed successfully.

Marked by seriousness
Rajya Sabha Chairman M Venkaiah Naidu said that the Winter Session was one marked by 'seriousness and brevity'. He said as against the total scheduled available time of 108 hours and 33 minutes with 20 sittings, the House functioned for 107 hours and 11 minutes, resulting in a productivity of 99 per cent.

Lok Sabha Speaker Om Birla said the lower House sat for 130 hours and 45 minutes in the 20 sittings during the Budget session. He said 140 starred questions were answered on the floor of the House and 934 matters of urgent public attention were raised during the session.

'Rape in India' jibe: BJP seeks Rahul Gandhi's apology

Parliament disrupted, but Congress leader refuses to say sorry

New Delhi, December 13

The last day of the Winter Session of Parliament ended in a burst of angry protests from BJP's women MPs led by Union Minister Smriti Irani who demanded that former Congress President Rahul Gandhi be punished for his remark that instead of "Make in India, BJP under Prime Minister Narendra Modi has turned the country into 'rape in India'."

Gandhi, on his part, came back with a stern, "I will never apologise to them."

The BJP's protest consumed the scheduled business of Lok Sabha and forced Speaker Om Birla to adjourn the proceedings twice.

Smriti slams Opposition

Smriti Irani was the most aggressive among the bunch of women MPs who stood around the Well of the House, asking the speaker Om Birla to "punish" Gandhi for what the Union Minister said was his attempt to turn a "heinous crime like rape as a tool to mock his political opponents".

Gandhi reiterated his comment made at an election rally in Jharkhand, which outraged

the BJP MPs and asserted that he would not apologise.

"I have a clip in the phone in which Narendra Modi is calling Delhi the 'rape capital'. The main issue is that the BJP, Narendra Modi and Amit Shah have set the North East on fire. To distract from that, they are attacking me on a non-issue. I want to reiterate what I said. I said - 'Narendra Modi said there will be make in India. But when we glance through the newspapers every day, we only say Rape in India.' That is what I said. The fact is that in the BJP-ruled States, women are being raped. In the Unnao rape case, the girl's car was attacked. The fact is that Modi spreads violence - in the North East, in Kashmir and against women.

And the economy, which was our biggest strength, has now been destroyed. So far as my apology is concerned, I will never apologise to them," said Gandhi.

'Politicising rape'

Irani accused Gandhi of politicising rape.

"The leader of a party gives a clarion call for raping women in India. It is for the first time in history that the scion of the Gandhi family has asked women to be raped. Is it his statement that every man wants to rape women in India? Are all men rapists? A Member of this House is uttering such sentences; he is asking women to be raped. Rahul Gandhi should be punished for committing this sin.

Come, rape in India. He is using rape as a political tool to mock his opponents," said Irani.

Union minister Rajnath Singh stating that leaders like him have no "moral right" to be in Parliament. Amid the din in the House, DMK's Kammozhi defended Gandhi and said he did not make the remarks in the House and that he was referring to cases of sexual assaults and violence against women in the country.

Earlier in the morning, as the ruckus continued for around half-an-hour, the Speaker adjourned the proceedings till noon. Question Hour could not be taken up. More than 30 members from the BJP, including Bhopal MP Pragya Thakur, were seen standing in the aisle and shouting slogans. Congress members, too, were in the aisle.

PTI adds: Later in the day, a delegation of BJP's women parliamentarians including Union minister Smriti Irani approached the Election Commission and demanded "strongest possible action" against Congress leader Rahul Gandhi for his comment on rape.

Irani charged Gandhi with using rape as a "political tool" in the wake of Assembly polls in Jharkhand.
