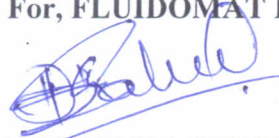

Public Health...

According to official data, the overall AQI was 504 at 3.30 am. An AQI between 0-50 is considered "good", 51-100 "satisfactory", 101-200 "moderate", 201-300 "poor", 301-400 "very poor", and 401-500 "severe". Above 500 is "severe-plus or emergency" category.

If the air quality persists in the "severe plus" category for more than 48 hours, emergency measures such as odd-even car rationing scheme, banning entry of trucks, construction activities and shutting down schools are taken under the Graded Response Action Plan (GRAP), the official said.

About 46 per cent of pollution in Delhi on Friday was caused due to stubble burning in neighbouring Punjab and Haryana, the highest this year, government agency SAFAR said.

Faced with the city turning into what he called a "gas chamber" and in accordance with the GRAP, Delhi Chief Minister Arvind Kejriwal said his government had decided to shut all schools till November 5. The odd-even scheme comes into force on November 4 for a fortnight.

"Please write letters to Captain uncle and Khattar uncle and say, 'Please think about our health'," he said in a message to children, referring to Punjab Chief Minister Amarinder Singh and Haryana's M L Khattar. The chief minister also met EPCA chairperson Bhure Lal and assured him of all cooperation in implementing the GRAP. In a letter to the chief secretaries of Delhi, Haryana, Rajasthan and UP, Lal sounded a warning.

"The air quality in Delhi and NCR deteriorated further last night and is now at the severe plus level. We have to take this as a public health emergency as it will have adverse health impacts on all, particularly our children," he wrote. Under these circumstances, he said, construction activities, hot mix plants and stone crushers in Delhi, Faridabad, Gurgaon, Ghaziabad, Noida and Greater Noida will remain closed till November 5.

Earlier, the EPCA had banned construction activities only for the period between 6 pm and 10 am till November 2. Now, no construction can take place even in daytime.

As Varsha tried to protect her mother from the trio, they entered the house and poured kerosene on girl's bed and set it ablaze. She sustained over 85% burn injuries. Trio fled from spot. So no one has been arrested so far."

PDP expels MP Lawa from party for attending swearing-in of LG

SRINAGAR: The PDP expelled its Rajya Sabha member Nazir Ahmad Lawa from party on Friday for "anti-party activities" after he had attended the swearing-in ceremony of the new Lieutenant Governor of Jammu and Kashmir.

"The member of Rajya Sabha, Nazir Ahmed Lawa, has been expelled from basic membership of the party," a PDP Democratic Party (PDP) spokesman said in a statement here.

The decision, he said, has been taken by the party leadership in view of Lawa's participation in the swearing-in ceremony of the newly appointed Lieutenant Governor in Srinagar undermining the party's stance.

He said that the participation of the party member in the swearing-in ceremony was in contravention to the party's stance regarding the current political situation and the revocation of Jammu and Kashmir's special status under Article 370 of the Constitution.

G C Murmu was on Thursday sworn in as lieutenant governor (L-G) of Jammu and Kashmir. The union territories of Jammu and Kashmir, and Ladakh, have been carved out of the state of Jammu and Kashmir in accordance with the government's August decision to revoke the special status of the state under Article 370 and bifurcate it into two UTs.

खरना का प्रसाद-चार दिवसीय महापर्व को हजारों श्रद्धालुओं ने व अन्य तालाबों में स्नान में स्नान करने के बाद के निर्जला उपवास के गवान सूर्य की पूजा कर

एक बार ही दूध और गुड़ से बनी खीर खाकर उपवास तोड़ेंगे। इसके बाद जब तक चांद नजर आएगा तब तक वह जल ग्रहण कर सकेंगे और उसके बाद से उनका करीब 36 घंटे का निराहार व्रत शुरू हो जाएगा। छठ का उपवास करने वाले श्रद्धालुओं ने शाम को गन्ने के रस और गुड़ की खीर और ठेकुआ बनाया। इसके बाद मिट्टी के बर्तन में खीर रखकर हवन किया। इसे परंपरा को खरना का प्रसाद कहा जाता है। इसके अलावा प्रसाद के रूप में चावल का पिठ्ठा और घी वाली रोटी भी बनाई गई। खरना के बाद सभी छठ व्रतधारियों का 36 घंटे का निर्जला उपवास शुरू हो गया है। वहीं, शुक्रवार को भी छठ व्रताधारियों ने सूप, नारियल, गन्ना, अनानस और केला आदि फलों की खरीदारी की।
