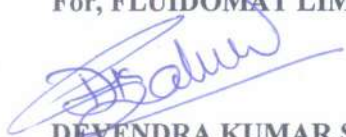

Prime Minister Narendra Modi has announced to observe August 14 as Partition Horrors Remembrance Day. A function was organised at National Institute of Technical Teachers Training and Research (NITTTR) here on Saturday wherein families who had suffered the pain of partition shared their memories. Shobha Lekhwani said that her grandparents were eyewitnesses of the partition. Along with independence, they also received pain as they became refugees in their own country after coming from Sindh province. Shobha narrated the ordeal in a manner that eyes of everyone became moist. Former Professor of NITTTR, Professor GT Lala, whose family migrated from Sindh after independence, said that his family left Pakistan and came to India.

Bundelkhand & Vindhya region gain
Rainfall deficit reduces
from 11% to 4% in 3 days

23 districts are still
rain deficient

Deficit in rainfall in the east division has reduced drastically in three days due to incessant rainfall last week. East division covers mainly Bundelkhand and Vindhya regions.

On August 13, east division has recorded 4pc deficit rainfall while on August 12 it was 7pc. On August 11, deficit was 9pc in the east division. So deficit is fast reducing in the east division. On August 10, the deficit was 11pc in east division.

On August 13, the state recorded 12pc surplus rainfall since June 1. East division recorded 4pc deficit while west division recorded 27pc surplus rainfall, according to the meteorological department.

East division recorded 629.1mm rainfall till August 13 while its normal rainfall

is 652.8mm. So it is 4pc deficit. West division recorded 701.6mm rainfall while its normal rainfall is 554.2mm. It is 27pc surplus rainfall. Overall the state recorded 670.1mm rainfall while its normal rainfall is 597mm. It is 12% surplus rainfall.

In the last 24 hours, Mawai recorded 17cm rainfall while Satna recorded 14 cm rainfall and Katni recorded 12cm. Similarly, Rampur Baghelan and Bichhiya recorded 11cm each. Nagod recorded 10cm and Gud recorded 9cm rainfall.

As many as 23 districts are rain deficient and 16 districts of them from east division are rain deficient. These are Panna, Rewa, Niwari, Narsinghpur, Anuppur, Chhatarpur, Damoh, Dindori, Jabalpur, Katni, Mandla, Umaria, Tikamgarh, Singrauli, Sidhi and Shahdol. Similarly, 7 districts in west division like Shivpuri, Morena, Jhabua, Dhar, Datia, Alirajpur and Bhind are rain deficient.
