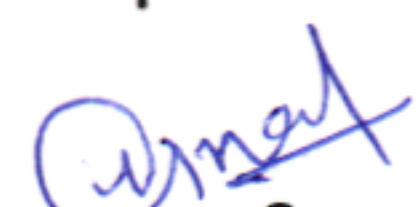

1. The explanatory statement pursuant to Section 102(1) of the Companies Act, 2013 setting out material facts regarding the items of special business specified above is annexed hereto along with the Postal Ballot Form for your consideration.
2. The Postal Ballot Notice is being sent to all the Members, whose names appear in the Register of Members / Beneficial Owners maintained by the Depositories as on cut-off date i.e. Tuesday, November 27, 2018
3. The Members whose name appears on the Register of Members/ Beneficial Owners maintained by the Depositories as on cut-off date i.e. Tuesday, November 27, 2018 will only be considered for the purpose of voting.
4. In compliance with provisions of Section 108 and 110 of the Companies Act, 2013 read with the rules made thereunder and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015, the Company is pleased to provide the e-voting facility to the Members to enable them to cast their votes electronically instead of postal ballot and has engaged services of National Securities Depository Limited ('NSDL') as the agency to provide e-voting facility. ANNEXURE TO THE NOTICE

EXPLANATORY STATEMENT PURSUANT TO SECTION 102 OF THE COMPANIES ACT, 2013

The Members may be aware that the liquid injectable plant located at Gummidipoondi, Tamil Nadu, specializes in manufacture of pharmaceutical formulations in injectable dosage and ophthalmic drops (here after referred to as CP4). CP4 has also a DSIR- approved in-house R&D facility and an additional R&D facility duly approved by DSIR located at Perungudi, Chennai (here after referred to as CP5), dedicated to the development of injectables and ophthalmics for catering the US and other regulated markets. This plant is approved by US FDA in October, 2016 and has successfully completed follow up audits in September, 2018 with a state of art technology.

The Company is in a constant endeavor to create a sustainable market share in the injectable segment in US and other regulated markets. To this end, the Company has an existing portfolio of injectable products as approved by US FDA and certain other products are in pipeline. Further, the Company has also accelerated the filings of ANDAs in its name.

The Company has made substantial investments in both capital and the operating expenditure of the injectable business. The said investments are entirely made from the internal accruals of the Company.

Keeping this in perspective as well as the fact that the Regulated Markets Injectable Business shall require a specific and a focused approach, the Board of Directors, in their meeting held on November 19, 2018, approved the transfer of the Regulated Markets Injectable Business to a separate entity which shall be a wholly owned subsidiary company.

The Board of Directors believes that the intended growth in the injectable segment can be better achieved through the wholly owned subsidiary company, since it shall facilitate:

- Further capitalization and need for additional investment in plant and machinery, building and capacity expansion
- Unlocking the value for the Company's Regulated Markets Injectable Business, as it is uniquely positioned to be run as a dedicated entity, targeted towards US and other regulated markets
- Exploring opportunities to attract "Capital plus Know-how" type of strategic partnerships for Regulated Markets Injectable Business, without any dilution in the Company.
- Separate business entity with focused strategy and growth path

In light of the above, the Board of Directors propose to transfer the business undertaking of the Company -Regulated Markets Injectable Business, including US FDA approved Injectable Plant and DSIR recognised R&D units CP4 and CP5, along with all related assets and liabilities including but not limited to employees, contracts, licenses, permits, consents, approvals, whatsoever to its Wholly Owned Subsidiary Company (Under Incorporation). The Regulated Markets Injectable Business, including US FDA approved Injectable Plant and DSIR recognised R&D units - CP4 and CP5 is proposed to be transferred as a going concern on a 'slump sale basis' to its wholly owned subsidiary company, for a lump sum consideration not less than its book value (determined by an independent Chartered Accountant) in accordance with the provisions of Section 50B read with Section 2(42C) of the Income-tax Act, 1961. The consideration will be fully discharged by the wholly owned subsidiary company by way of issue of shares.

Section 180(1)(a) of the Companies Act, 2013 ('the Act') provides that the Board of Directors of a company shall not, except with the consent of the members by way of special resolution through postal ballot, sell, lease or otherwise dispose of the whole, or substantially the whole, of the undertaking of the company. Further, explanation (i) to Section 180(1)(a) of the Act, provides that the expression 'undertaking' for the purposes of Section 180(1)(a) of the Act shall mean an undertaking in which the investment of the company exceeds 20% of its net worth as per the audited balance sheet of the preceding financial year or an undertaking which generates 20% of the total income of the company during the previous financial year. Since the proposed transfer of the Regulated Markets Injectable Business exceeds the specified limits mentioned above, the resolution in the accompanying notice is proposed to seek approval of the Members through a special resolution.

Your Directors recommend the resolution for the approval of Members by way of special resolution.

None of the Directors, Key Managerial Personnel or their relatives are in any way concerned or interested in this resolution except to the extent of their shareholding in the Company, if any.
