e-VOTING CUT-OFF DATE :

The e-Voting rights of the shareholders/beneficiary owners shall be reckoned on the equity shares held by them as on Tuesday, the 19th July, 2016 **being the Cut-off date for the purpose.** Shareholders of the Bank holding shares either in physical or in dematerialized form, as on the Cut-off date, may cast their vote electronically on the agenda items **other than Election of Shareholder Directors.**
