Suven Life secures Two (2) Product Patents in Europe and Hong kong

HYDERABAD, INDIA (May 13, 2015) – Suven Life Sciences Ltd (Suven) announces today that the grant of one (1) product patent from Europe (2758394) and one (1) product patent from Hong kong (1173140) corresponding to their New Chemical Entities (NCEs) for the treatment of disorders associated with Neurodegenerative diseases.

The granted claims of the patents include the class of **selective 5-HT compounds discovered by Suven** and are being developed as therapeutic agents and are useful in the treatment of cognitive impairment associated with neurodegenerative disorders like Alzheimer's disease, Attention deficient hyperactivity disorder (ADHD), Huntington's disease, Parkinson and Schizophrenia.

With these new patents, Suven has a total of **sixteen (16) granted patents from Europe and seventeen (17) product patents from Hong Kong**. These granted patents are exclusive intellectual property of Suven and are achieved through the **internal discovery research** efforts. Products out of these inventions may be out-licensed at various phases of clinical development like at Phase-I or Phase-II.
