We would request you to please advise your members not to deal with the aforesaid shares.

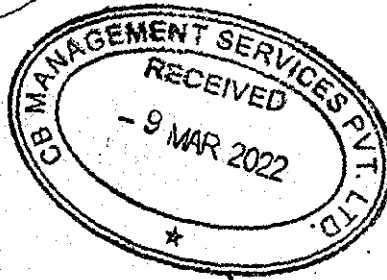

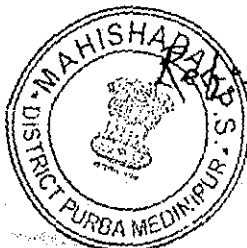
