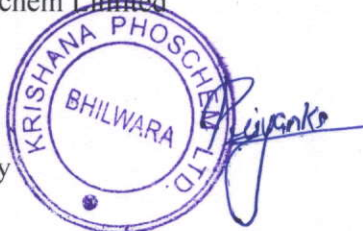

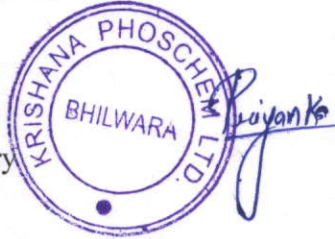

I have indeed been very fortunate for having associated with Management and the Board and I thank you for your cooperation extended during my tenure.

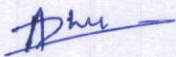
