Re: Rating Letter for INR 7.5bn Non-Convertible Debenture Programme

India Ratings and Research (Ind-Ra) has downgraded Tata Teleservices (Maharashtra) Limited's (TTML) Long-Term Issuer Rating and the rating on its INR7.5 billion non-convertible debentures (NCDs) to 'IND A' from 'IND A+'. The Outlook is Negative.

In issuing and maintaining its ratings, India Ratings relies on factual information it receives from issuers and underwriters and from other sources India Ratings believes to be credible. 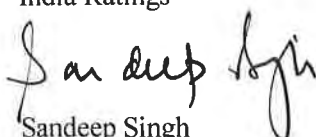
