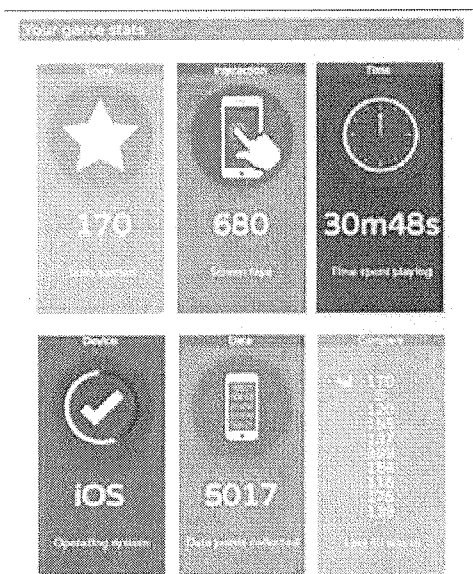
YES BANK 1st organization in India to introduce 'Gamification Round' for hiring at premium B-Schools

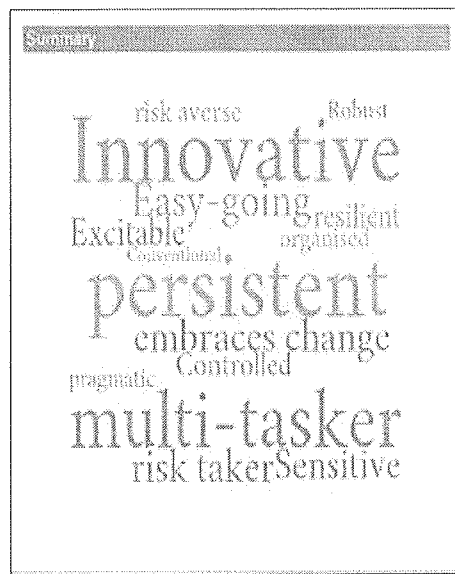

This highly interactive gamification app helps evaluate the following competencies of candidates that are specially customized in line with the Bank's core ethics:

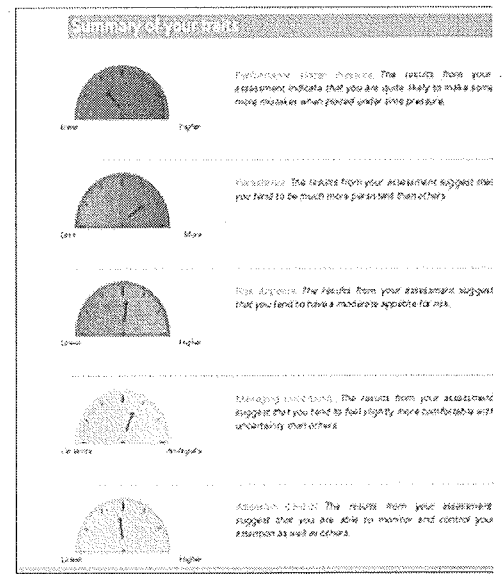
