1. Kindly refer to our letter of even number dated 18.12.2017 informing that the Securities and Exchange Board of India (SEBI) vide its letter no. CFD/CMD/OW/ 31781/1/2017 dated 15.12.2017 has permitted the Company to raise capital by issue of equity shares to the extent of 10% of the present paid up equity capital of the Company by utilizing QIP as a method under Clause 2 (vii) of the SEBI Circular CIR/CFD/CMD/14/2015 dated 30.11.2015 so as to achieve minimum level of public shareholding as required under Rule 19A of the Securities Contracts Regulation (Rules), 1957.
