Please refer our letter dated OCL/BSE/2020-21/ 88, dated 11th December, 2020 wherein we have requested time till 31.03.2021 to pay the annual listing fees. But we wish to inform that due to poor performance during the current year due to PANDEMIC COVID-19 and its consequences viz. uncertain times and difficult circumstances due to strict COVID-19 safety protocols announced by Central and State Governments the marriage functions and other social gatherings were drastically came down which in turn drastically reduced the sales of Wedding Cards for marriages and other social gatherings to which major business of our company belongs to which in turn the volume of sales was very very pathetic due to COVID-19 compared to the previous year's 9 months sales(Sales for the 9 months period ended 31.12.2020, was Rs.686.82 Lakhs compared to Rs.2538.82 Lakhs of the previous year's sales for the 9 months ended 31.12.2019). Due to these reasons the financial position of the company has become very poor.

In view of the above we request you to kindly consider and grant us time for further period upto 30th June, 2021 for payment of Annual Listing Fee as a SPECIAL CASE due to very poor performance during the current year due to PANDEMIC COVID-19 and its consequences as stated above.
