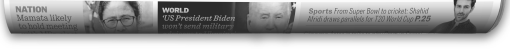

The statutory auditors have carried out an audit of the statement of SNL Bearings Limited ('Company') for the year ended 31 March 2026.
- The statement has been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standards (Ind AS), prescribed under Section 133 of the Companies Act, 2013 (the 'Act') and other accounting principles generally accepted in India. The statement is in compliance with the presentation and disclosure requirements of Regulation 33 of SEBI (Listing Obligation and Disclosure Requirement) Regulations, 2015 (as amended).
- Effective 21 November 2025, the Government of India has consolidated multiple existing labour legislations into unified framework comprising of four Labour codes - the Code on Wages, 2019 the Industrial Relations Code, 2020, the Code on Social Security, 2020, and the Occupational Safety, Health and Working Conditions Code, 2020. As per the evaluation done by the Company on the basis of the information and guidance available as on date, the Company has recorded the 'statutory impact' due to the change in definition of wages as per the new labour code in employee benefit expenses.
