With reference to you letter L/SURV/ONL/PV/KS/2022-2023/2194 received by email on 08TH April 2022.

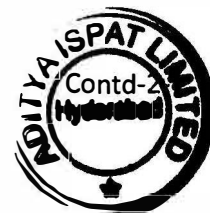
