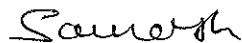

Fitch retains Lodha's 'B' rating

New Delhi, June 9

FITCH HAS AFFIRMED realty firm Lodha Developers' credit rating at 'B' and maintained negative outlook, even as the company's sales booking rose to over ₹6,900 crore last fiscal despite demonetisation.

Fitch said it might consider revising the outlook to 'Stable' if the Mumbai-based developer addresses its near-term domestic debt maturities, and secure sustained financing for the London project.

Lodha group has projects in Mumbai, Pune and London property markets.

"Fitch Ratings has affirmed India-based home builder Lodha Developers Pvt Ltd's Long-Term Issuer Default Rating (IDR) at 'B', and maintained the negative outlook," the rating agency said.

The affirmation of Lodha's IDR reflects the company's healthy pre-sales and cash col-

lections in the 2016-17 fiscal in spite of weak domestic demand for real estate, it said.

Lodha's sales bookings improved to ₹6,920 crore in FY17 from ₹6,430 crore in FY16, amid weaker domestic demand for property, especially against

the backdrop of demonetisation. "Surprisingly, demand for Lodha's projects were somewhat less impacted in the December quarter compared with most of the other large Indian home builders that Fitch tracks," the rating agency said.

Lodha's sales bookings bounced back strongly in February and March this year, Fitch said. It attributed this to the advanced stage of completion of

many of its large projects as well as the view that the adverse effects of demonetisation on large homebuilders appear to have passed.

Strong sales in FY17 were also supported by the company's affordable housing project at Pallava. Lodha's cash collections improved significantly to ₹7,620 crore from ₹6,070 crore during the period under review. Fitch expects the company's pre-sales to remain broadly flat around ₹7,000 crore in the current fiscal.

The rating agency said, "the negative outlook reflect the near-term risks to the company's credit profile, in particular refinancing risk associated with sizeable maturities, including financing for its London project, over the next 12 months". Although Lodha has access to domestic funding sources, Fitch said the company has not yet communicated a detailed refinancing plan for its upcoming maturities.

Trump's policies could have adverse impact on biz: Wipro

IT MAJOR WIPRO has listed US President Donald Trump's policies as a risk factor that could impact its business, citing promotion of "greater restrictions on free trade" among key worrying points.

The Bengaluru-based firm which earned 52% of its IT services revenue from the Americas, including the US, said significant developments stemming from the US presidential election could have a material adverse effect on its business. As a candidate, Trump and his administration had expressed support for policies impacting existing trade agreements, like North America Free trade agreement (NAFTA), and proposed trade agreements, Wipro said in an SEC filing.

In its annual report for the fiscal ended March 31, 2017 filed with the market regulator, Wipro further said Trump administration has been "promoting greater restrictions on free trade generally and significant increases on tariffs on goods imported into the United States".

It added: "Changes in US social, political, regulatory and economic conditions or in laws and policies governing foreign trade, manufacturing, development and investment in the territories and countries where we currently operate could adversely affect our business." The company had reported net sales of ₹55,420.9 crore in the fiscal ended March 31, 2017.

After assuming office last year, Trump has taken several steps, including H1B visa restrictions, that raised concerns in the Indian IT sector.

Adani's ₹1,270-cr container terminal at Kamarajar Port goes on stream

THE ₹1,270-CRORE container terminal project developed by Adani group at Kamarajar Port near here has gone on stream.

The terminal was inaugurated by union minister of transport, highways and shipping Nitin Gadkari on Friday. The union shipping minister also inaugurated three other projects, including ₹152 crore Chettinad group's multi-cargo terminal, an e-office and RFID system at the port premises. All these four projects were set up with an estimated cost of ₹1,492 crore. Adani group's ₹1,270 crore container terminal was developed under design, build, finance, operate and transfer basis.

The terminal will have an annual capacity of 1.4 million twenty foot equivalent units (MTEUs). The multi-cargo terminal developed by Chettinad group will have an annual capacity of 2 million tonne per annum.

With the commissioning of these terminals, the capacity of Kamarajar Port has taken a quantum jump from 32 MTPA to 50 MTPA immediately and will touch 90 MTPA when on-going projects are completed in 2 years.

ब्रिटेन में हुए आम चुनाव में भारतीय मूल के दो ब्रितानी उम्मीदवारों प्रीत कौर गिल और तनमनजीत सिंह ने जीत दर्ज की है। प्रीत पहली सिख महिला सांसद और तनमनजीत पहले पगड़ीधारी सांसद होंगे। प्रीत ने बर्मिंघम एनबास्टरन सीट 24, 124 वोटों से जीती हैं। उन्होंने कंजर्वेंटिव पार्टी के उम्मीदवार कैरोलिनस्वधार को 6,917 मतों के अंतर से हराया है। उन्होंने कहा, ‘मैं खुश हूँ कि मुझे एजबास्टन का अगला सांसद बनने का मौका दिया गया। यहां मेरा जन्म हुआ और मेरी परवरिश हुई। मैं मेहनत और लगन के साथ एजबास्टन की जनता के साथ सहयोग बढ़ाना चाहती हूं। मुझे लगता है कि हम मिलकर बड़े लक्ष्य हासिल कर सकते हैं। जीत दर्ज करने वाले दूसरे उम्मीदवार तनमनजीत सिंह देसाई जिन्हें तान के नाम से भी जाना जाता है, ने स्लोघ सीट 34, 170 मतों से जीत हासिल किया है। देसाई ने कहा कि वे उस शहर की सेवा करना चाहते हैं जहां उनका जन्म हुआ है। सिख फेडरेशन यूके ने कहा कि सारा श्रेय लेबर पार्टी को जाता है।

कोलंबिया के मानवाधिकार कार्यकर्ता को मारी गोली

बोगोटा, 9 जून (एएफपी)।

उत्तरी कोलंबिया में अज्ञात हमलावरों ने एक मानवाधिकार कार्यकर्ता की गोली मार कर हत्या कर दी। नेशनल एसोसिएशन ऑफ डिसप्लेस्ड एफ्रोडेसेंडेट्स (एफ्रोड्स) के मुताबिक बनाई क्यूरो की हत्या बुधवार को उनके मलबों के घर पर हुई। बनार्डो ने एफ्रोड्स के लिए एक वकील के रूप में काम किया था। संगठन ने बताया कि पीड़ितों के लिए अपना जीवन समर्पित कर देने वाले मानवाधिकार कार्यकर्ता, पिता, भाई, दोस्त बनार्डो क्यूरो ब्रावो की हत्या की हम कड़ी निंदा करते हैं। संगठन ने बताया कि दो बंदूकधारी एक मोटरसाइकिल पर सवार होकर क्यूरो के घर आए और उनकी साथी और अन्य परिजनों की उपस्थिति में उन्हें गोली मारकर फरार हो गए। क्यूरो का संबंध कई अन्य क्षेत्रीय मानवाधिकार संगठनों के साथ था। अमेरिका महादीपों के लिए एमेनेस्टी इंटरनेशनल की निदेशक एरिका गेवारा रोसास ने क्यूरो की हत्या की निंदा की है और एक बयान में कहा है कि देश में अफ्रीकी-कोलंबियाई लोगों के अधिकारों के लिए लड़ने वालों के जीवन और सुरक्षा की गारंटी के लिए सरकार को आवश्यक सुरक्षात्मक उपायों वाले कदम उठाने चाहिए।
