This decision has been taken in view of the Company's existing printing machinery is underperformance arising from technological obsolescence, suboptimal operational capacity, and frequent maintenance-related shutdowns. These issues have resulted in increased inefficiencies and inconsistencies in cost and operations and the proceeds from the sale, if any, will be utilized to strengthen the core business and exploring avenues for adopting advanced technologies.
