In continuation of our letters dated October 30, 2025 and November 06, 2025, wherein the Company had informed about the proposal for acquisition of 100% equity shares of TCI Global (Singapore) Pte. Ltd. from TCI Holdings Asia Pacific Pte. Ltd., a step-down wholly owned subsidiary of Transport Corporation of India Limited, by TCI Express Pte. Ltd., a wholly owned subsidiary of TCI Express Limited.
