Reg: Notice for proposed Strike by United Forum of Bank Unions (UFBU)

This is to inform that United Forum of Bank Unions (UBFU) has given a notice to IBA calling for All India Bank Strike from 25.02.2015 to 28.02.2015, for immediate settlement of wage revision, 5 day banking, improvement in pension scheme, improvement in other perquisites and allowances and regulated working hours to officers.

If the strike materialises, a certain section of the Bank's employees may participate in the proposed strike on the said dates, in which case, it is likely that the normal functioning of the branches / offices of the Bank may get affected.

The Bank is taking all necessary steps in terms of the existing guidelines for smooth functioning of Bank's branches / offices to deal with the strike.

The information is furnished pursuant to Clause 36 of the Listing Agreement.
