Sub: Intimation pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Dear Sir,

This is in continuation of our intimation dated 13th May, 2025 and 2nd July, 2025 regarding imposition of penalty by BSE Limited for non-compliance of Regulation 17(1) and 17(1A) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. The matter was placed before the Board of Directors at its meeting held today. It was informed to the Board that the Company paid penalty of Rs.1,95,000/- plus GST of Rs.35,100/- on 2nd July, 2025 in compliance with the email dated 1st July, 2025 imposing penalty under Regulation 17(1) and 17 (1A). The attention of the Board was also drawn that while the penalty under Regulation 17(1A) was reversed by the National Stock Exchange of India Limited vide their letter dated 28th February, 2025 but was not considered favorably by BSE Limited and accordingly the Company paid the penalty as mentioned above.

The Board discussed the matter and after discussion noted the same and advised to be more careful in future to avoid any such incidents.
