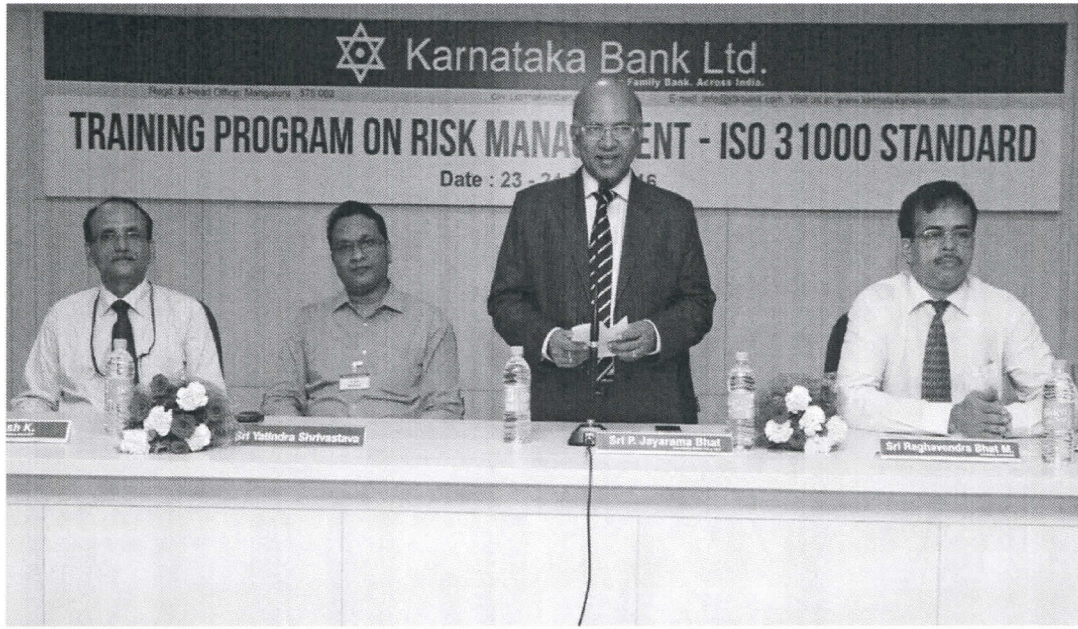

Karnataka Bank holds ISO 31000 Programme on Risk Management:

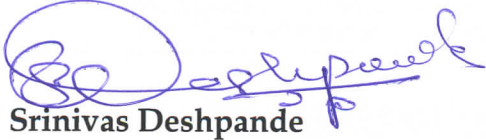
