#### To the Shareholders of DCC plc

Dear Shareholder

The Notice of the Thirty Sixth Annual General Meeting of DCC plc to be held on Friday 20 July 2012 at 11.00 a.m. in The Four Seasons Hotel, Simmonscourt Road, Ballsbridge, Dublin 4, Ireland is set out on pages 4 to 9 of this document.

The resolutions to be proposed at the Annual General Meeting are set out in detail in the Notice and explanatory notes on the resolutions are set out below.

#### **Ordinary Business (Resolutions 1 to 5)**

#### **Resolution 1 – Financial Statements**

Resolution 1 deals with the consideration of the financial statements of the Company for the year ended 31 March 2012. A full copy of the 2012 Annual Report and Accounts is available on the Company's website www.dcc.ie.

## Resolution 2 – Dividend

Resolution 2 deals with the declaration of a final dividend of 50.47 cent per ordinary share for the year ended 31 March 2012. If approved, the final dividend will be paid on 26 July 2012 to shareholders on the register at the close of business on 25 May 2012. This will give a total dividend for the year of 77.89 cent, which represents a 5% increase on the prior year.

#### Resolution 3 – Report on Directors' Remuneration and Interests

Resolution 3 deals with the approval of the Report on Directors' Remuneration and Interests as set out on pages 74 to 83 of the Annual Report and Accounts. Since 2009, it has been the Board's practice to put the Report on Directors' Remuneration and Interests to a shareholder vote. There is no legal obligation on the Company to put such a resolution to shareholders, so it is an 'advisory' resolution and is not binding on the Company. DCC believes that such a resolution is an appropriate acknowledgement of a shareholder's right to have a 'say on pay'.

#### **Resolution 4 – Re-election of Directors**

Resolution 4 deals with the proposed re-election of all of the Directors. Since 2008, it has been the Board's practice that all Directors will submit to re-election at each Annual General Meeting. This practice meets the requirement set out in the UK Corporate Governance Code which was issued in June 2010, under which all directors are subject to annual election by shareholders.

The Board undertakes a formal annual evaluation of its Directors. This year, the entire performance evaluation process was externally defined and conducted by Towers Watson in accordance with Provision B.6.2 of the UK Corporate Governance Code. The Board is satisfied that all of the Directors proposed for re-election performed effectively in offering independent and constructive challenge to management, have made an appropriate contribution to strategy development and have committed sufficient time to DCC Board affairs.

Brief biographies of the Directors, including a statement as to why their qualifications and experience are relevant to their role as Directors, are set out on pages 56 and 57 of the Annual Report and Accounts.

The re-election of each Director will be considered separately.

## **Resolution 5 – Remuneration of the Auditors**

Resolution 5 authorises the Directors to determine the remuneration of the Auditors.

#### **Special Business (Resolutions 6 to 10)**

Resolutions 6 to 10 in the Notice of Meeting seek your approval for a number of items of special business.

Resolutions 6 to 8 are the usual annual resolutions which relate to the share capital of the Company and propose to renew authorities previously approved by shareholders. The Directors will exercise these authorities only if they consider it to be in the best interests of shareholders generally at that time.

Resolution 9 relates to the fixing of the price range in which treasury shares may be re-issued.

Resolution 10 relates to the notice period for the convening of an extraordinary general meeting.

Each of these resolutions 6 to 10 is dealt with in more detail below.

#### Resolution 6 – Authority to allot shares

Resolution 6 will be proposed as an Ordinary Resolution to authorise the Directors to allot shares up to an aggregate nominal amount of €7,352,400, representing approximately one third of the Company's issued share capital on 13 June 2012.

This authority will, if renewed, expire on the earlier of the date of the next Annual General Meeting of the Company or 19 October 2013.

#### Resolution 7 – Disapplication of pre-emption rights

Resolution 7 will be proposed as a Special Resolution to renew the Directors' authority to issue shares for cash other than strictly pro-rata to existing shareholdings. The proposed authority is limited to the allotment of shares in specific circumstances relating to rights issues or any other issues up to an aggregate nominal amount of €1,102,800, representing approximately 5% of the Company's issued share capital on 13 June 2012.

This authority will, if renewed, expire on the earlier of the date of the next Annual General Meeting of the Company or 19 October 2013.

## Resolution 8 - Authority to purchase own shares

Resolution 8 will be proposed as a Special Resolution to renew the authority of the Company, or any subsidiary, to make market purchases of up to 10% of the aggregate nominal value of the Company's issued share capital and to hold these shares as treasury shares or cancel them at the Directors' discretion. The resolution also sets out the minimum and maximum prices that may be paid for shares purchased in this manner.

If the Directors were to exercise the authority being renewed by this resolution up to the maximum number of shares allowed and to cancel such shares and all other shares held in treasury, the total number of options to subscribe for ordinary shares in the Company (which, on 13 June 2012, is 2,157,755, representing 2.4% of the issued share capital) would represent 2.9% of the issued share capital.

This authority will, if renewed, expire on the earlier of the date of the next Annual General Meeting of the Company or 19 January 2014.

## Resolution 9 – Re-issue price of treasury shares

Resolution 9 will be proposed as a Special Resolution to authorise the Company to re-issue treasury shares offmarket at certain specified minimum and maximum prices.

This authority will, if renewed, expire on the earlier of the date of the next Annual General Meeting of the Company or 19 January 2014.

#### Resolution 10 – Notice period for extraordinary general meetings

Resolution 10 will be proposed as a Special Resolution to maintain the existing authority in the Articles of Association that allows the Company to convene an extraordinary general meeting on 14 days' notice where the purpose of the meeting is to consider an ordinary resolution.

## Form of Proxy

Those shareholders unable to attend the Meeting may appoint a proxy. Your proxy may be submitted by post by completing the enclosed Form of Proxy and returning it to the Company's Registrar, Computershare Investor Services (Ireland) Limited, PO Box 954, Heron House, Corrig Road, Sandyford Industrial Estate, Dublin 18, Ireland. Your proxy may also be submitted through the internet; instructions on how to do this are set out on the Form of Proxy. CREST members who wish to appoint a proxy or proxies via the CREST electronic proxy appointment service should refer to footnote 5 on page 8 of this document.

All proxy votes must be received by the Company's Registrar not less than 48 hours before the time appointed for the Meeting or any adjournment of the Meeting. The submission of a proxy will not prevent you attending and voting at the Meeting should you wish to do so.

#### Recommendation

The Directors are satisfied that the resolutions set out in the Notice of the Annual General Meeting are in the best interests of the Company and its shareholders. Accordingly, the Directors unanimously recommend you to vote in favour of each of the resolutions set out in the attached Notice, as they intend to do in respect of all the ordinary shares which they own or control in the capital of the Company.
