Dear Shareholder

The Notice of the Thirty Ninth Annual General Meeting of DCC plc to be held on Friday 17 July 2015 at 11.00 a.m. in the InterContinental Hotel. Simmonscourt Road. Ballsbridge. Dublin 4. Ireland is set out on pages 4 to 8 of this document.

The resolutions to be proposed at the Annual General Meeting are set out in detail in the Notice and explanatory notes on the resolutions are set out below.

Resolution 1 – Financial Statements

Resolution 1 deals with the consideration of the financial statements of the Company for the year ended 31 March 2015. A full copy of the 2015 Annual Report and Accounts is available on the Company's website www.dcc.ie.

Resolution 2 – Dividend

Resolution 2 deals with the declaration of a final dividend of 55.81 pence per ordinary share for the year ended 31 March 2015. If approved, the final dividend will be paid on 23 July 2015 to shareholders on the register at the close of business on 29 May 2015. This will give a total dividend for the year of 84.54 pence per ordinary share, which represents a 10% increase on the prior year.

Resolution 3 – Remuneration Report

Resolution 3 deals with the consideration of the Remuneration Report (excluding the Remuneration Policy) as set out on pages 82 to 100 of the 2015 Annual Report and Accounts.

It had been the Company's practice since 2009 to put the Remuneration Report to an advisory, non-binding shareholder vote at each Annual General Meeting. In 2014, two separate advisory, non-binding resolutions on the Remuneration Policy and on the Annual Report on Remuneration were put to shareholders. At this Annual General Meeting, the Remuneration Report (excluding the Remuneration Policy) will be put to an advisory, non-binding shareholder vote. As the Remuneration Policy remains unchanged from last year, it will not be put to a shareholder vote.

Resolution 4 – Re-election of Directors

Resolution 4 deals with the proposed re-election of all of the Directors. Since 2008, it has been the Board's practice that all Directors will submit to re-election at each Annual General Meeting. This practice meets the requirement that all directors are subject to annual election by shareholders, as set out in the UK Corporate Governance Code.

The Board undertakes a formal annual evaluation of its Directors and is satisfied that all of the Directors proposed for re-election performed effectively in offering independent and constructive challenge to management and have committed sufficient time to discharge their responsibilities effectively.

Brief biographies of the Directors, including their key strengths and experience relevant to their role as Directors, are set out on pages 70 and 71 of the 2015 Annual Report and Accounts.

The re-election of each Director will be considered separately.

Resolution 5 – Appointment of KPMG as Auditors

Resolution 5 deals with the proposed appointment of KPMG as auditors of the Company.

During the year, the Audit Committee engaged in a formal tender process for the external audit of the Group's financial statements. Following the conclusion of this process, the Board approved the appointment of KPMG as auditors of the Company. This appointment is being put to shareholders for their approval at this Annual General Meeting. Full details of the tender process are set out on pages 79 to 80 of the 2015 Annual Report and Accounts.

Resolution 6 - Remuneration of the Auditors

Resolution 6 authorises the Directors to determine the remuneration of the Auditors.

Resolution 7 – Authority to allot shares

Resolution 7 will be proposed as an Ordinary Resolution to authorise the Directors to allot shares up to an aggregate nominal amount of €7,368,600, representing approximately one third of the Company's issued share capital (excluding Treasury Shares) on 16 June 2015.

This authority will, if renewed, expire on the earlier of the date of the next Annual General Meeting of the Company or 16 October 2016.

Resolution 8 – Disapplication of pre-emption rights

Resolution 8 will be proposed as a Special Resolution to renew the Directors' authority to issue shares for cash other than strictly pro-rata to existing shareholdings. The proposed authority is limited to the allotment of shares in specific circumstances relating to rights issues or any other issues up to an aggregate nominal amount of €1,105,200, representing approximately 5% of the Company's issued share capital (excluding Treasury Shares) on 16 June 2015.

This authority will, if renewed, expire on the earlier of the date of the next Annual General Meeting of the Company or 16 October 2016.

Resolution 9 – Authority to purchase own shares

Resolution 9 will be proposed as a Special Resolution to renew the authority of the Company, or any subsidiary, to make market purchases of up to 10% of the aggregate nominal value of the Company's issued share capital (excluding Treasury Shares) and to hold these shares as treasury shares or cancel them at the Directors' discretion. The resolution also sets out the minimum and maximum prices that may be paid for shares purchased in this manner.

If the Directors were to exercise the authority being renewed by this resolution up to the maximum number of shares allowed, the total number of options to subscribe for ordinary shares in the Company (which, on 16 June 2015, is 1,173,620, representing 1.3% of the issued share capital (excluding Treasury Shares)) would represent 1.5% of the issued share capital (excluding Treasury Shares).

This authority will, if renewed, expire on the earlier of the date of the next Annual General Meeting of the Company or 16 January 2017.

In relation to Resolutions 7 to 9, the Directors will exercise these authorities only if they consider it to be in the best interests of shareholders generally at that time.

Resolution 10 – Re-issue price of treasury shares

Resolution 10 will be proposed as a Special Resolution to authorise the Company to re-issue treasury shares off-market at certain specified minimum and maximum prices.

This authority will, if renewed, expire on the earlier of the date of the next Annual General Meeting of the Company or 16 January 2017.

Resolution 11 - Notice period for extraordinary general meetings

Resolution 11 will be proposed as a Special Resolution to maintain the existing authority in the Articles of Association that allows the Company to convene an extraordinary general meeting on 14 days' notice where the purpose of the meeting is to consider an ordinary resolution.

Resolutions 12 and 13 - Amendments to the Memorandum and Articles of Association

Resolutions 12 and 13 will be proposed as Special Resolutions to amend particular clauses in the Memorandum of Association of the Company and to approve and adopt new Articles of Association of the Company to give effect to certain changes arising as a consequence of the new Companies Act 2014. The changes reflect the new statutory references in the Companies Act 2014 and some further changes are being proposed to:-

- Amend Article 15 to give the Directors power to convert a share, over which the Company has a lien, from uncertificated to certificated form;
- Include a new Article 73(b) to clarify that Section 228(1)(d) of the Companies Act 2014 will not prohibit the directors using the Company's property, subject to any restrictions imposed by the Company;
- Include a new Article 88(e) to clarify that Section 228(1)(e) of the Companies Act 2014 will not prohibit a director entering into any commitment which has been approved by the Board and provide that a Director must obtain the prior approval of the Board before entering into any commitment permitted by Section 228 of the Companies Act 2014; and
- Amend Article 114 to take account of the new requirements concerning accounting records in the Companies Act 2014.

A copy of the Memorandum and Articles of Association, amended to reflect (and marked up to highlight) the proposed changes, is available on the Company's website www.dcc.ie and may be inspected at the registered office of the Company during business hours until the close of the Annual General Meeting. A copy may also be inspected at the Annual General Meeting.

All proxy votes must be received by the Company's Registrar not less than 48 hours before the time appointed for the Meeting or any adjournment of the Meeting. The submission of a proxy will not prevent you attending and voting at the Meeting should you wish to do so.

Recommendation

The Directors are satisfied that the resolutions set out in the Notice of the Annual General Meeting are in the best interests of the Company and its shareholders.
