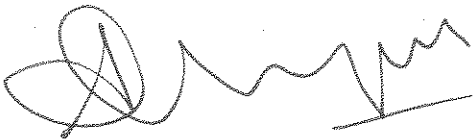

On Consolidated basis:

For the quarter ended 31st December 2013, Net Sales increased by 9.16% to Rs. 391.6 Crores from Rs. 358.7 Crores during the same quarter last year and Profit after Tax & Minority Interest is at Rs. 42.16 Crores against Rs. 9.36 Crores during the same quarter last year.

For the nine months ended 31st December 2013, Net Sales have grown by 3.86% to Rs. 1094.6 Crores from Rs. 1053.9 Crores during the same period last year and Profit after Tax & Minority Interest is at Rs. 53.9 Crores against Rs. 24.6 Crores during the same period last year.

On Standalone basis:

For the quarter ended 31st December 2013, Net Sales stood at Rs. 263 Crores from Rs. 273.7 Crores during the same quarter last year and Profit after Tax increased to Rs. 36.9 Crores against Rs. 6.81 Crores during the same quarter last year.

For the nine months ended 31st December 2013, Net Sales stood at Rs. 752.9 Crores from Rs. 810.1 Crores during the same period last year and Profit after Tax increased to Rs. 41.1 Crores against Rs. 19.0 Crores during the same period last year.
