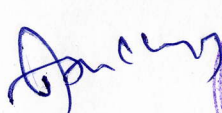
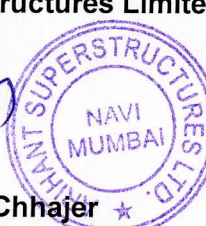

**EXPLANATORY STATEMENT TO THE ANNUAL GENERAL MEETING NOTICE
(Under Section 102 of Companies Act, 2013)**

The following Statement sets out all material facts relating to the Special Business mentioned in the Notice:

Item No. 09: Appointment of Ms. Namrata Thakker (DIN 08478260) as the Woman Independent Director of the Company for first term of five years

Pursuant to the provisions of Section 149 of the Companies Act, 2013, the Company is required to appoint Independent and Woman Director on the Board of the Company.

In compliance with the above provisions, the Board of Directors, upon the recommendation of the Nomination and Remuneration Committee by way of passing the circular resolution on 1st September, 2023, had appointed Ms. Namrata Thakker (DIN 08478260) as an Additional Director, in the category of Independent and Woman Director with effect from 01st September, 2023 who shall hold office upto the date of the ensuing AGM.

The said appointment is in line with the Nomination & Remuneration Policy of the Company.

The Company has received from Ms. Namrata Thakker (DIN 08478260) (i) consent in writing to act as director in Form DIR 2 pursuant to Rule 8 of Companies (Appointment & Qualification of Directors) Rules, 2014, (ii) intimation in Form DIR 8 in terms of Companies (Appointment & Qualification of Directors) Rules, 2014, to the effect that she is not disqualified under sub-section (2) of Section 164 of the Companies Act, 2013, and (iii) a declaration to the effect that she meets the criteria of independence as provided in sub-section (6) of Section 149 of the Companies Act, 2013.
