4. That the HOUSTON Court case is bound to be decided in favour of your company because the out of Court Settlement was done at US\$ 80 million. Out of which a sum of US\$ 40 million received. For the balance we need US\$ 40 million required to be paid with accrued interest @6% and Attorney fee, aggregating to about Rs.120 Crore. Therefore, the company is in litigation for these claims and we are sure to get the amount in times ahead.
