Pursuant to the above, we hereby inform that our Board of Directors at its Meeting held on 29th May 2025 has approved for :

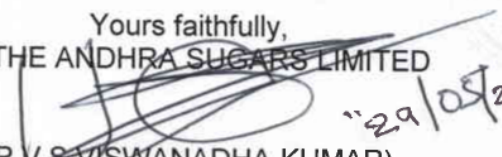
- Closure of Sugar Unit and Co-Generation Unit at Tanuku due to Non-availability of Viable quantities of Sugar Cane for past few seasons.

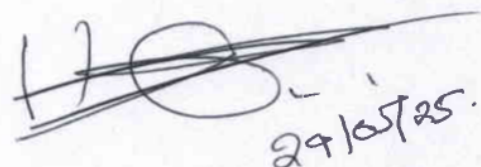
