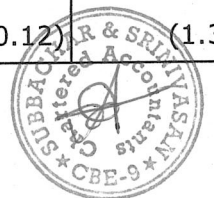

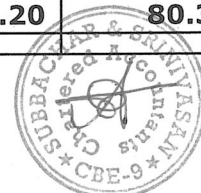

1.
