Once the GST record is fixed by NSDL and CDSL we will release the payment and shareholding pattern and investor grievance redressal report will also be generated.

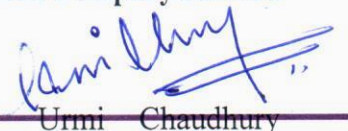
Therefore we request you for waiving off the penalty, noting the reference that there has not been any non-compliance at the end of the company and kindly grant us some more time to meet the compliance.
