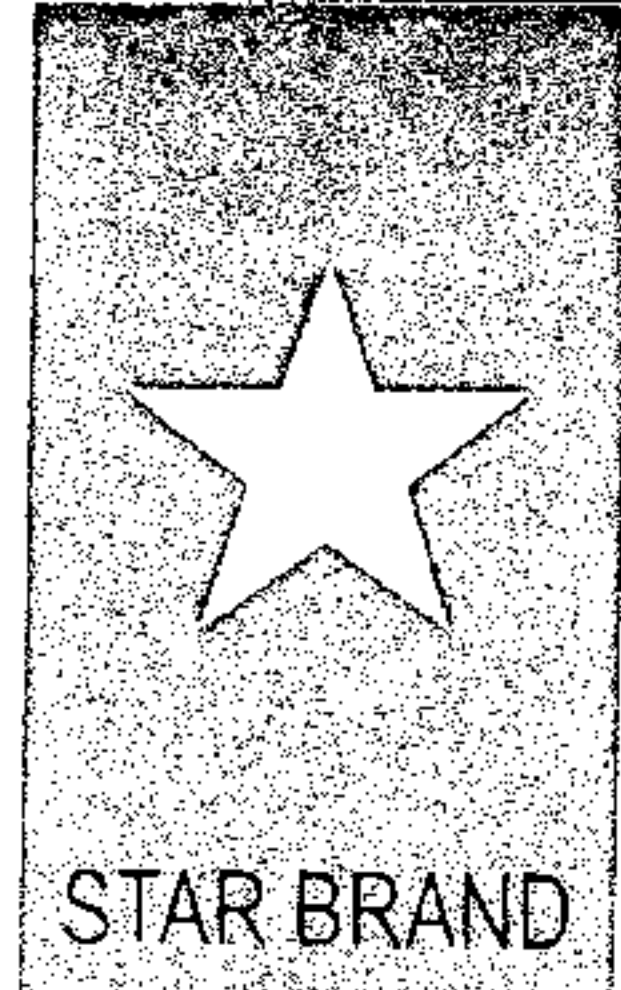

Sub: Intimation of 78th AGM, fixation of Book-Closure and E-voting details and other important matters

Kindly take on record the following intimation please:

(a) The 78th Annual General Meeting of the company will be held on **Thursday, 14th September, 2017** at Kolkata (W.B).

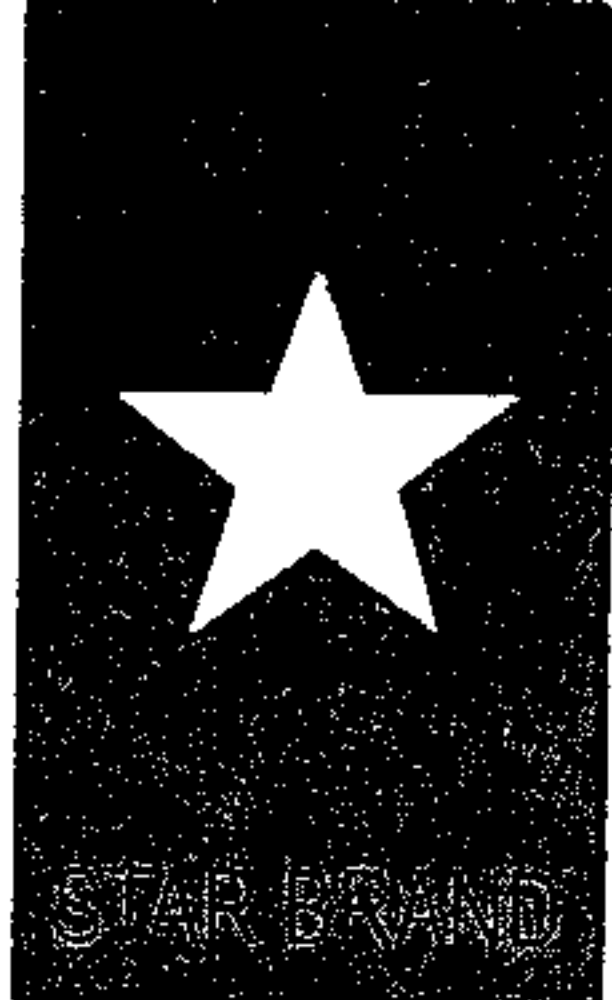

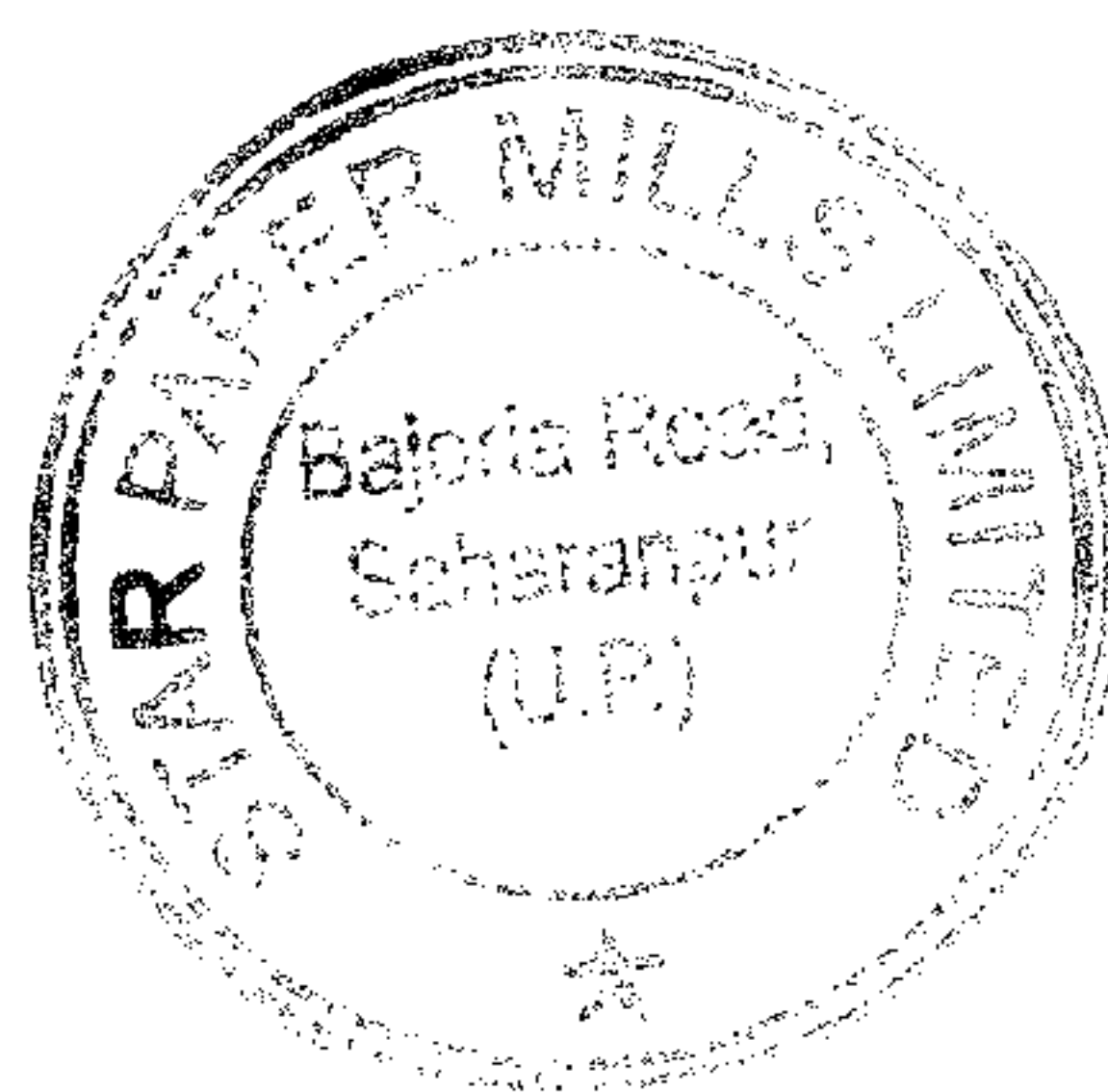
