## आरोग्य साहाय्य समितीने आवाज उठवल्यामुळे कोपरखैरणे येथील ‘सीटी स्कॅन सेंटर’ने ५ जणांची अतिरिक्त आकारलेली रक्कम केली परत !

नवी मुंबई, दि.२८: महाराष्ट्र शासनाने कोरोना रुग्णांसाठी वैद्यकीय उपचार आणि तपासणी यांसाठी दर निश्चित केले आहेत. असे असतांनाही ‘कुलकर्णी निदान डायग्नोस्टिक सेंटर’ने महाराष्ट्र शासनाचे नियम डावलून कोपरखैरणे येथील श्री. जयदीप शेडगे आणि त्यांच्या कुटुंबातील चार सदस्य असे एकूण ५ जणांची ‘सीटी स्कॅन’च्या नावाखाली प्रत्येकी १,५०० रुपये प्रमाणे ७,५०० रुपये जास्त रक्कम आकारली. याविषयी ‘आरोग्य साहाय्य समिती’ने संबंधित ‘डायग्नोस्टिक सेंटर’कडे पत्रव्यवहार करून योग्य कारवाई करण्यास सांगितले असता त्यांनी आकारलेली अधिकची रक्कम शेडगे कुटुंबियांना परत केली आहे. श्री. शेडगे यांनी ‘आरोग्य साहाय्य समिती’ आणि ‘सुराज्य अभियान’ यांच्या ‘सुराज्य की ओर’ या ऑनलाईन कार्यक्रम तून प्रेरणा घेऊन अन्यायाविरुद्ध आवाज उठवला असल्याचे म्हटले आहे.

कोपरखैरणे येथील शेडगे कुटुंबातील एकूण ५ जण कोरोना पॉझिटिव्ह

होते. त्यांच्या सीटी स्कॅन अहवालामध्ये ते कोरोना संक्रमित असल्याचे स्पष्ट दिसत होते; म्हणजेच त्यांना न्युमोनियाचा संसर्ग झाल्याचेही स्पष्ट दिसत होते. तरीही त्यांच्याकडून प्रत्येकी २,५०० रुपयांच्या एवजी ४,००० रुपये आकारण्यात आले. म्हणजे प्रत्येकी १,५०० रुपये प्रमाणे ५ जणांचे एकूण ७,५०० रुपये अतिरिक्त घेण्यात आले. श्री. शेडगे यांनी ‘आरोग्य साहाय्य समिती’कडे यासंदर्भात साहाय्य मागितले असता समितीने त्यांना महाराष्ट्र शासनाच्या २४ सप्टेंबर २०२० च्या शासन निर्णयाचा दाखला देऊन कोरोना रुग्णाच्या सीटी स्कॅनसाठी २,५०० रुपये घेण्याचा नियम असल्याचे सांगितले. समितीने केलेल्या मार्गदर्शानुसार श्री. शेडगे यांनी ‘कुलकर्णी निदान डायग्नोस्टिक सेंटर’कडे याविषयी तक्रार केली. श्री. शेडगे यांनी तक्रार करतांना डॉक्टरांचे तपासणीसाठीचे पत्र, त्यांचे देयक, तपासणी अहवाल आणि महाराष्ट्र शासनाचा निर्णय इत्यादी सर्व कागदपत्रे जोडली. या तक्रारीत ‘डायग्नोस्टिक

सेंटर’ने दोन दिवसांत निर्णय घेऊन अतिरिक्त रक्कम परत करावी, अशी मागणी केली. ‘आरोग्य साहाय्य समिती’ने या डायग्नोस्टिक सेंटरला सर्व कागदपत्रे पाठवून श्री. शेडगे यांच्या तक्रारी संदर्भात तातडीने दखल घेण्यास सूचित केले. त्यानुसार ‘डायग्नोस्टिक सेंटर’ने श्री. शेडगे यांना एकूण ७,५०० रुपये परत केले.

महाराष्ट्र शासनाच्या निर्णयानुसार कोरोना रुग्णांच्या छातीचा सीटी स्कॅन केल्यावर २,५०० रुपये एवढे शुल्क आकारणे बंधनकारक आहे. असे असतांनाही सीटी स्कॅनची अतिरिक्त दराचे आकारणी करून अनेक सामान्य रुग्णांची फसवणूक केली जात आहे. तरी छातीची सीटी स्कॅन तपासणी करतांना आणि कोरोनाचे अन्य उपचार घेतांना शासन निर्णयानुसार देयक आकारले जात असल्याची खात्री करावी, असे आवाहन ‘आरोग्य साहाय्य समिती’ने सर्व नागरिकांना केले आहे.

## नाशिक जिल्ह्यात आजपर्यंत ३ लाख ६४ हजार ४१९ रुग्ण कोरोनामुक्त

नाशिक, दि.२८: जिल्हा सामान्य रुग्णालयामार्फत आज प्राप्त अहवालानुसार जिल्ह्यातील ३ लाख ६४ हजार ४१९ कोरोना बाधीतांना डिस्चार्ज देण्यात आला असून सद्यस्थितीत १३ हजार ९७२ रुग्णांवर उपचार सुरु आहेत. तसेच उपचार सुरू असलेल्या रुग्णांमध्ये ४२५ ने घट झाली आहे. आतापर्यंत ४ हजार ५७० रुग्णांचा मृत्यू झाला आहे, अशी माहिती जिल्हा नोडल अधिकारी डॉ. अनंत पवार यांनी दिली आहे. उपचार घेत असलेले पॉझिटिव्ह रुग्ण : नाशिक ग्रामीण मध्ये नाशिक १ हजार १२८, बागलण ५९६, चांदवड ५८१, देवळा ५१५, दिंडोरी ६५४, इगतपुरी १३४, कळण ५२७, मालेगाव ५१९, नांदगाव ४३६, निफाड ९२६, पेठ ४७, सिन्नर ६८१, सुरगाणा

१३७, खंबकेश्वर ६५, येवला १०८ असे एकूण ७ हजार १०६ पॉझिटिव्ह रुग्णांवर उपचार आहे. तसेच नाशिक महानगरपालिका क्षेत्रात ५ हजार ८७९, मालेगांव महानगरपालिका क्षेत्रात ८७७ तर जिल्ह्याबाहेरील एकही रुग्ण नसून असे एकूण १३ हजार ९७२ रुग्णांवर उपचार सुरु आहेत. तसेच आजपर्यंत जिल्ह्यात ३ लाख ८२ हजार ९४१ रुग्ण आढळून आले आहेत. रुग्ण बरे होण्याची टक्केवारी जिल्ह्यात रुग्ण बरे होण्याची टक्केवारी नाशिक ग्रामीण मध्ये ९३.५१ टक्के, नाशिक शहरात ९६.४८ टक्के, मालेगाव मध्ये ८९.५१ टक्के तर जिल्हा बाह्य रुग्णांचे बरे होण्याचे प्रमाण ९८.०५ टक्के आहे. तसेच जिल्ह्यात बरे होण्याचे प्रमाण ९९.१६ टक्के आहे.

अलिबाग, जि. रायगड, दि.२८ (हिंदुस्थान समाचार) : मागील वर्षी निसर्ग व यावर्षी तोटे चक्रीवादळांमुळे जिल्ह्यात मोठ्या प्रमाणात नुकसान झाले आहे. विशेषतः समुद्र किनाऱ्यालगतच्या गावांचे मोठे नुकसान झाले असून झाडांची मोठ्या प्रमाणात पडझड झाली आहे. जैवविविधतेचे अस्तित्व ठेवून निसर्गासोबतची जीवनशैली निश्चित करण्यासाठी शासन आग्रही आहे. जागतिक तापमान वाढीचे संकट व हवेचे प्रदूषण कमी करण्यासाठी तसेच पर्यावरणाचे संतुलन राखण्यासाठी जंगलांची वाढ ही काळाची गरज आहे.

या बार्बिना प्राधान्य देण्यासाठी जिल्ह्यातील सर्व ग्रामपंचायत हद्दीत मोठ्या प्रमाणात वृक्ष लागवड मोहीम राबविण्याचा संकल्प रायगड जिल्हा परिषदेने केला आहे. रायगड जिल्हा परिषद अध्यक्ष योगिता पारधी, उपाध्यक्ष सुधाकर घारे, मुख्य कार्यकारी अधिकारी डॉ. किरण पाटील यांच्या मार्गदर्शनाखाली रायगड जिल्हा परिषदेचे कृषी विकास अधिकारी लक्ष्मण खुरकुटे, जिल्हा कार्यक्रम व्यवस्थापक जनयवंत गायकवाड, माहिती शिक्षण व संवाद तज्ञ सुरेश राजाराम पाटील व सर्व गटविकास अधिकारी यांच्या समन्वयातून ही मोहीम यशस्वी करण्याचा निर्धार करण्यात आला आहे.

यासाठी जिल्ह्यातील सर्व सरपंच व ग्रामसेवक यांना जिल्हा परिषदेमार्फत पत्राद्वारे आवाहनही करण्यात आले आहे. ही वृक्षलागवड ग्रामपंचायत कार्यालय, शाळा, अंगणवाडी, प्राथमिक आरोग्य केंद्र, तलाठी कार्यालय, पडीक जमीन, शेताचे बांध, महामार्गाच्या दूतर्फा, पशुवैद्यकीय दवाखाने आदींच्या परिसरांमध्ये लावावीत, अशा सूचना देण्यात आल्या असून वृक्ष लागवडीची पूर्वतयारी म्हणजे जागा निवड, रोपांची उपलब्धता, आणि खड्डे खोदणे, ही कार्यवाही दि. ३१ मे २०२१ पर्यंत करण्याच्या व अगस्त २०२१ अखेर वृक्ष लागवड पूर्ण करण्याच्या सूचना देण्यात आल्या आहेत.

या मोहिमेत भारतीय प्रजातीची झाडे म्हणजे वड,

पिंपळ, आंबा, नारळ, सुपारी, काजू, चिंच, शेवगा अशी झाडे लावण्यास प्राधान्य देण्यात येणार आहे. ग्रामपंचायती त्यांच्या मर्जीनुसार अन्य झाडेही लावू शकतात.

त्याचबरोबर लावलेली झाडे जतन करण्यासाठी झाडाभोवती संरक्षक जाळी बसविणे आवश्यक आहे, ग्रामपंचायतने रोपे लागवडीची नोंद रजिष्टरमध्ये करावी, ही झाडे संवर्धनासाठी नागरिकांना व संस्थांना घावीत, मुख्य रस्त्यापासून पाच ते सहा मीटर अंतरावर ही झाडे लावावीत, भविष्यात ही झाडे कोणत्याही इमारतीवर पडून मालमतेचे नुकसान होणार नाही, असे नियोजन करण्याच्या सूचना प्रशासनाकडून देण्यात आल्या आहेत.
