This is in reference to the above stated email, we request you to kindly take note of our submissions to the queries raised by your good office regarding outcome of Board Meeting held on 09th April, 2019. We hereby submit/clarify the following:

1. Reasons for Closure- Lack of Business Opportunity at Cash segment, BSE Limited (BSE). However, we continue to hold the Cash and Derivative segment of National Stock Exchange of India Limited (NSE). In Case in future, if any opportunity is there, we will become client of some BSE broker or can even take membership again based on requirements at that time..

2. Date of Closure - On and from 26th April, 2019, we shall not be trading on the Cash segment of BSE.

Estimated time of closure- the whole process is likely to take eight to nine months time.
