We refer to our letter dated August 2, 2012 wherein we had informed that the holding of the Schemes of HDFC Mutual Fund in Onmobile Global Limited ("the Company") was 5.43% of the paid up equity share capital of the Company (Paid up Equity Share Capital being Rs. 113,93,93,100/- comprising 11,39,39,310 equity shares of Rs. 10/- each).

Further, in accordance with the captioned regulation and other applicable laws / regulations, if any, we wish to inform you that there has been a **decrease** in the shareholding of the Company by the Schemes of HDFC Mutual Fund by **3.32%** as of June 21, 2013. 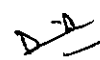
