(c) The Auditor's in their Review Report on the standalone financial statement for the period ended 30 September, 2020 have brought out that: The Company has a non-current investment of Rs. 1,513.13 crores (net of impairment provision) and inter corporate deposits (classified under current assets) of Rs. 25 crores recoverable from Sinner Thermal Power Limited (formerly Rattandindia Nasik Power Limited) (STPL), a wholly owned subsidiary of the Company, as at 30 September 2020. The subsidiary company has incurred losses since its inception and is yet to commence operations. The accumulated losses in the subsidiary company amount to Rs. 6,284.59 crores as at 30 September 2020, and the management of the subsidiary company had determined that a material uncertainty exists as at 30 September 2020, that may cast significant doubt about the subsidiary company's ability to continue as a going concern. The management of the Company, based on an internal estimate, has recorded an impairment of Rs. 1,513.13 crores against carrying value of investment in STPL in prior year. In the absence of evidence for such impairment assessment performed by the management, we are unable to obtain sufficient appropriate evidence to comment on any adjustment that may further be required to be made to the balance carrying value of the above mentioned non-current investment of Rs. 1,513.13 crores and inter corporate deposits of Rs. 25 crores as at 30 September 2020 and the consequential impact thereof on the accompanying standalone financial results.
