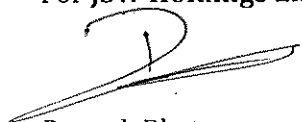

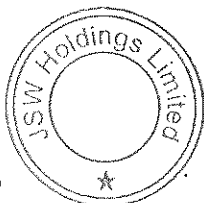

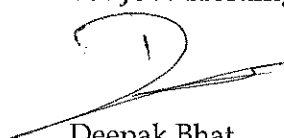
Closure of Trading Window as per "SEBI (Prohibition of Insider Trading) Regulations, 2015"
