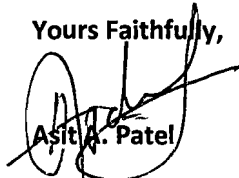

1. Arvindbhai Tribhovandas Patel HUF (holding 150445 shares in other demat account), being part of promoter group was erroneously mentioned in the list of public and have been added to promoter's group aggregating his Shareholding as 165102 equity shares.
2. Pursuant to extinguishment of Equity Shares in the Buyback during the year, the paid up Equity Share Capital of the Company has reduced from Rs. 15,15,53,270 of Rs. 10 each to Rs. 13,66,00,000 of Rs. 10 each and consequently the voting rights of the Promoter and Promoter Group ('Promoter') post-buyback increased to more than 2%. The Promoters have submitted report with SEBI under regulation 10(7) of the takeover regulations on March 08, 2016 seeking exemption under that regulation.
