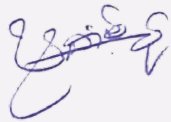

Consequent to the above, Enzotech become a wholly-owned subsidiary of Banka BioLoo Limited. The details, as required under listing Regulations, read with SEBI Circular No. CIR/CFD/CMD/4/2015 dated 9 September 2015 with respect to acquisition of Enzotech, have, already, been submitted to the exchange vide our intimations dated 14 February 2022 and 19 February 2022.
