In this regards you may also refer to PTC's Annual Report for FY 2018-19 in which items covering for proposal of monetization of subsidiary Companies are recommended.

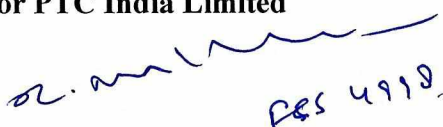
