Sub: Intimation under Clause 36 of the Listing Agreement

Dear Sir / Madam,

1. This is in furtherance of our letter dated 01 April 2014, wherein we had informed you about a press release issued by Alstom, France on 01 April 2014 in respect of its agreement to sell its auxiliary components business to Triton, a leading European investment firm.
2. We would like to inform you that, today the Company has received a letter from Alstom Finance B.V. dated 04 April 2014 requesting the Board of Directors to consider the proposal for disposal by the Company of its auxiliary components business to an Indian legal entity to be specified by Triton, as a going concern on a slump-sale basis, subject to receipt of all relevant corporate consents and in accordance with applicable laws.
3. This activity is part of the non-core asset disposal programme, announced by Alstom, France in November 2013. The auxiliary components business proposed to be sold is part of the steam segment within Thermal Power and is active both in the new equipment market and aftermarket services across three product lines: air preheaters and gas-gas heaters for thermal power plants, heat transfer solutions for a variety of petrochemical and industrial processes, and grinding mills for diversified industrial applications.
4. Alstom Finance B.V. has requested the Company to consider the proposal favourably and commence the requisite process under Indian law including determination of the fair valuation of the Auxiliary Components Business/Undertaking and obtaining relevant consents to implement the aforesaid proposal.

This information is being given in accordance with Clause 36 of the Listing Agreement.
