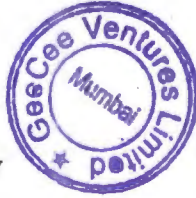

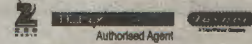

After months of searches and questions, a South African teenager and an American lawyer recently found debris on separate occasions off the coast of Mozambique, renewing

hopes of solving the major aviation mystery.

"I would like to acknowledge the work undertaken by the Australian Transport Safety Bureau, Geoscience Australia, Boeing and Australian National University which assisted the Malaysian Investigation Team with their examination of the debris," Chester said, adding that "the search for MH370 continues". There are 25,000 square kilometres of the underwater search area still to be searched.

Weather records showed that winds in the area about that time increased from 23 to 40 miles per hour (37 to 64 kilometers per hour), and the seas were rough with high waves. When the ship didn't arrive as scheduled at Pearl Harbor some 2,400 miles away, the Navy launched a massive sea and air search operation, but focused its efforts around Hawaii.
