Pursuant to Clause 35A of the Listing Agreement kindly find enclosed results of Postal Ballot and E-voting process.

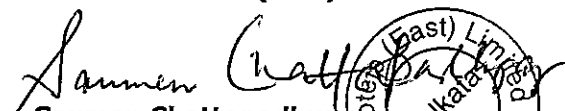

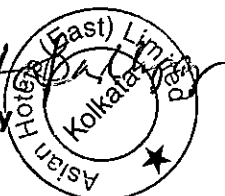

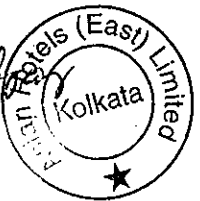
