I, Atul Kumar Labh, Practising Company Secretary (FCS – 4848 / CP - 3238) and proprietor of M/s. A. K. Labh & Co., Company Secretaries, Kolkata was appointed as the scrutinizer in connection with the Extra-Ordinary General Meeting (“EGM”) of the members of “**Duroply Industries Limited**” (“Company”) held on Monday, the 8th day of August, 2022 at 11:00 A.M. I submit my report as under:

1. The remote e-voting period remained open from 09.00 A.M. IST on Friday, the 5th day of August, 2022 up to 5.00 P.M. IST on Sunday, the 7th day of August, 2022.
2. The shareholders holding shares as on the "cut off" date, i.e. the 1st day of August, 2022 were entitled to vote on the proposed 4 (Four) resolutions as mentioned in the Notice of the EGM dated the 13th day of July, 2022.
3. The Company had also provided e-voting facility at the EGM to enable the shareholders attending the EGM through VC / OAVM to cast the votes in case the same had not been cast by them through remote e-voting.
4. The votes were unblocked on Monday, the 8th day of August, 2022 around 11:50 A.M. IST after the completion of the EGM in the presence of two witnesses, namely, Mr. Narayan Chandra Saha, residing at 108, Sarat Chatterjee Road, Howrah – 711102 and Mrs. Anushree Dasgupta, residing at 28/N, Dwijen Mukherjee Road, Behala, Kolkata – 700060, who are not in employment of the Company.
