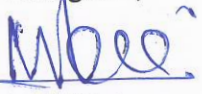

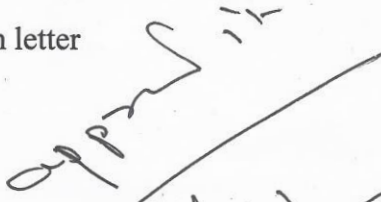
Therefore, I kindly request the management to accept my resignation and relieve me from my duties with the effect from the closure of business hours on 07/11/2025
