Profit after Tax increased by 36% in the present period to Rs.60.47 crore from Rs.44.57 crore reported in the corresponding previous period.

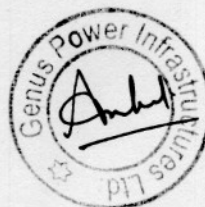
EPS for the half year is Rs.3.24 (Face Value of Share: Re.1).
