विदेशी मुद्रा भंडार बढ़कर रेकॉर्ड 507.64 अरब डॉलर पर

मुंबई, 20 जून (भाषा)।

देश का विदेशी मुद्रा भंडार 12 जून को समाप्त सप्ताह में 5.942 अरब डॉलर की पर्याप्त वृद्धि के साथ 507.644 अरब डॉलर के सर्वकालिक उच्च स्तर को छू गया। सप्ताह के दौरान विदेशी मुद्रा आस्तियों के बढ़ने से यह वृद्धि हुई है।

रिजर्व बैंक के आंकड़ों के अनुसार इससे पूर्व पांच जून को समाप्त सप्ताह में देश का विदेशी मुद्रा भंडार पहली बार 500 अरब डॉलर के स्तर को लांच गया था जब यह 48.22 अरब डॉलर बढ़कर 501.703 अरब डॉलर पर पहुंचा था। समीक्षाधीन सप्ताह में कुल मुद्रा भंडार का महत्वपूर्ण घटक यानी विदेशी मुद्रा आस्तियां 5.106 अरब डॉलर बढ़कर 468.737 अरब डॉलर हो गई।

अर्थशास्त्रियों के अनुसार विदेशी मुद्रा भंडार में वृद्धि का कारण अधिक पूंजी निवेश होना और चालू खाते के घाटे का कम होना था। कोविड-19 महामारी के कारण उत्पन्न व्यवधानों की वजह से कारोबारी गतिविधियों में सुस्ती आई है। उन्होंने कहा कि विदेशी मुद्रा भंडार की यह जमा धनराशि एक

साल के आयात के खर्च के बराबर है। समीक्षाधीन सप्ताह में स्वर्ण आरक्षित भंडार 82.1 करोड़ डॉलर बढ़कर 33.173 अरब डॉलर हो गया।
